Terms and Conditions - Entries for Group S Bathurst 12 Hour 2018



Event : Bathurst 12 Hour – February 2nd-4th, 2018

This is a **GSRA member only** event. All entries will be administered by the **Group S Racing Association**. Entry acceptance will be at the discretion of the Group S Racing Association Committee. An entry will be deemed 'complete' when **all documentation** (see below) **and Entry Deposit** are received.

Entry form:

To be completed and forwarded to president@groupsracing.org.au, and to include:

- Copy of the logbook for the vehicle entered (showing logbook number)
- Copy of CAMS licence for the driver entered
- Picture of vehicle entered
- Payment via EFT Group S Racing Association Inc. BSB # 112-879 --- Acc # 155610760

Entries open: 1st June 2017 Entries close: 31st October 2017

<u>Maximum grid</u>: 55 (TBC) <u>Entry Deposit</u>: \$800* payable with entry form

Reserve List: Unlimited Balance of Entry: \$800* payable by 15.11.2017

Failure to pay the balance of the Entry Fee by 15.11.2017 will result in the entrant forgoing their position on the entry list.

Terms and Conditions - Entries for Group S Bathurst 12 Hour 2018



Entry Acceptance:

GSRA will accept entries on a first come basis, however reserve all rights to accept or deny entries based on, but not limited to, the following criteria:

- 1. Driving Standards of the entered Driver in Group S events since 1.1.2016
- 2. The number of Group S events entered since 1.1.2016
- 3. The overall vehicle condition, both visually and mechanically
- 4. The entered Driver's racing experience and CAMS Licence level (note NO provisional licences are eligible. Clubman or National Circuit are acceptable)
- 5. Expected Vehicle & Driver lap times around Bathurst (130% rule will be enforced)
- 6. Membership status (current and historical)

Refund policy:

The GSRA will provide refunds subject receiving an email to president@groupsracing.org.au based on the terms below:

- 90% refund of funds paid if cancellation received before 31.10.2017
- 50% refund of funds paid if cancellation received between 1.11.2017 31.12.2017
- 0% refund after 1.1.2018
- 100% refund if your entry was not accepted due to over subscription, or denied by the GSRA.

Terms and Conditions - Entries for Group S Bathurst 12 Hour 2018



Reserve List:

- The GSRA will endeavor to run a 'Reserve List', whereby a predetermined number of competitors over the maximum 'grid density' will be allowed to Practice and Qualify.
- The number of Reserve List cars will be determined and communicated at a later date with those that have paid in full prior to the Entries Closing date.
- Those on the Reserve List will be able to join the race (starting rear of grid) in the event that another competitor is unable to continue for the weekend, either through mechanical failure, or driving standards.
- The aim is to provide as many members the opportunity to race, but also where possible to ensure the grid capacity is utilized for every race.
- A payment refund structure for those on the Reserve List <u>only</u>, will be communicated at a later date to those that have paid in full prior to the Entries Closing date.

Entry Inclusions:

- 1 x Race Entry; comprising of 1 x Practice, 1 x Qualifying, 3 x Races (minimum)
- 1 x Marquee space for race car (including power)
- 4 x General Admission entry tickets
- Note: No tender vehicles or trailer will be allowed in the paddock area.
